







Terms and conditions

- § 1 The processing of online orders will be governed solely by the following terms and conditions. The Customer's contrary terms and conditions will remain invalid, even if these are not repudiated by Software & Support Media GmbH in each specific instance. The contract concerning the publication of online advertising for the purpose of being published on the websites of Software & Support Media GmbH will be called the "online contract" for the purpose of the following terms and conditions.
- **§2 Conclusion of contract** The contract is established upon acceptance of the online advertising. The contractual partner will receive a legally binding confirmation of order. Amendments and supplements to any contract must, as a rule, be made in writing and must be initialled by both parties in order to become effective. These terms and conditions apply exclusively with respect to the conclusion of contract and the execution of the order as well as the price list valid at the time of the conclusion of contract and which constitutes an integral part of this contract.
- § 3 Non-disclosure agreement The customer must not disclose any services and prices confirmed to any third parties. In case of violation, Software & Support Media GmbH reserves the right to claim compensation for damages.
- §4 Cancellation Unless otherwise specifically agreed, the cancellation of an online contract by the Customer is possible before online presentation and for a maximum period of two weeks following the confirmation of order sent by Software & Support Media GmbH. The notice to cancel must be issued in writing. Cancellations made after this time will require the Customer to pay the full fee. In the event of a failure to fulfil a master agreement, the Customer will be required to pay Software & Support Media GmbH the difference between the discount granted and the discount corresponding to the actual number of adverts placed. If the said fulfilment is impeded due to reasons for which Software & Support Media GmbH is responsible, the duty of reimbursement will be extinguished.

- §5 Services, publication Software & Support Media GmbH undertakes to only publish on the Internet the current online advertising as commissioned by the Customer. The service provided by Software and Support Media GmbH is based on the contract concluded by both parties. It cannot guarantee that services will not be provided to competitors. The services agreed in the contract are exclusively for the customer. Products and services from third parties may not be advertised without the agreement of Software & Support Media. - §6 Fee for services The fee for the services to be provided by Software & Support Media GmbH is based on the price list published in the media data. - §7 Provision for costs and payment arrangements The fee defined in Paragraph 5 encompasses all additional costs such as email, telephone, fax, data transfer costs, postage and photocopies to the usual extent. The invoice will be issued following the expiry of the time of publication as specified in the order. In the event of default or deferral of payments, interest and collection costs will be charged. In the event of a default of payment, Software & Support Media GmbH will be entitled to suspend further performance of the order until such time as full payment is made. All prices stated are subject to the statutory rate of VAT applicable at the time of billing.
- §8 Basis of the cooperation Software & Support Media GmbH will undertake to continuously optimise the response to Customer ads and to boost the quantity and quality of visits. Software & Support Media GmbH reserves the right not to publish Customer orders on the internet or to remove orders already published on the internet, if this is materially justified given the respective content or origins. This applies especially if the data to be displayed violates statutory or public-law prohibitions or off ends public decency or if Software & Support Media GmbH can not be reasonably expected to allow the publication. The implementation of such a step does not entitle the Customer to claim reimbursements from Software & Support Media GmbH. §9 Copyright All working results created during the fulfilment of this contract, whether legally protected or not, and in relation to the associated documentation, will become the property of Software & Support Media GmbH upon being created, specifically in their respective state of development. The payment made by the Customer and the presentation of the working results on the internet by Software & Support Media GmbH does not entail the assignment of rights of exploitation or use. The rights created in relation to the working results accrue to Software & Support Media GmbH with respect to all types of use and without restriction in relation to time or content.

§ 10 Warranty Software & Support Media GmbH warrants faults in accordance with the statutory regulations. No claims exist in relation to faults which only impair the fitness of the service to an insignificant extent. Faults must be promptly reported to the Customer, in any case no later than 7 days following publication of the services on the internet. Software & Support Media GmbH is entitled to perform subsequent improvement by way of extending the time of the publication.

§11 Liability / disclaimer Software & Support Media GmbH is only liable for failure to perform the services due and the duties existing, if the said breach is a result of its deliberate act or gross negligence. All other liability on the part of Software & Support Media GmbH is hereby excluded. Software & Support Media GmbH is not liable for the accuracy of the published information or the material statements this information contains. Software & Support Media GmbH is not liable for the infringement of third-party competition or trademark rights or copyright not recognised by it or which it was not bound to recognise. Liability for copyright infringements resulting from data and files provided by the Customer is expressly excluded. Editorial responsibility and responsibility relating to competition law and any other applicable regulations for the advertising copy supplied lies solely with the Customer. By placing the order the Customer confirms that it has acquired all the rights of use from the owners of the copyright, ancillary copyright and other rights to the documents and data provided by it as are required for placement on the internet, or that is entitled to exercise said rights without restriction. §12 Data protection The Customer is hereby notified in accordance with Section 33 para. 1 Federal Data Protection Act that Software & Support Media GmbH will store its data in a machinereadable form and process this data automatically for the purpose of the contract.

§13 Duration The time period agreed in the contract begins with the online status of online advertising and automatically expires at the end of the agreed term. A subsequent shift or change is ruled out, unless otherwise agreed.

§14 Miscellaneous The contract including interpretation thereof is governed by German and European law. Disputes arising out of this agreement will be heard before the competent court in Frankfurt am Main. Frankfurt am Main is the place of performance for all legal arrangements existing between Software & Support Media GmbH and the Customer. Amendments and additions to this contract, including any ancillary agreements and amendments to this clause, must be made in writing and signed by both parties in order to be valid. Any delay, omission or failure to exercise a right on the part of Software & Support Media GmbH does not constitute a waiver. If any of the conditions of this agreement are found to be invalid or become invalid through future statutory provisions, this will not affect the validity of the remaining provisions of this agreement. In such a case the parties are duty bound to substitute the invalid provision with a valid one which most closely fulfi Is the purpose of the original, particularly considering the commercial objectives of the parties. The same applies in the event that any gap requiring augmentation is discovered during performance of this contract.
